**Important Notices:**

**Once you have completed this form in its entirety, including all required signatures and file it with the Board of Supervisors of Elections for the Town of Chestertown, the entity named herein must open a bank account designated solely for this purpose and begin raising and spending money.**

**To serve as a treasurer an individual must be a registered voter in the Town of Chestertown.**

**The treasurer is responsible for all receipts and expenditures of the committee. All assets received by or on behalf of the campaign finance entity must pass through the hands of the treasurer.**

**Additionally, only the treasurer can disburse campaign funds. Maryland law requires that the treasurer keep a detailed and accurate account book on behalf of the campaign finance entity.**

**A treasurer may not serve “in name only” and may not delegate and responsibility to another person, including the candidate.**

I am a registered voter of the Town of Chestertown in Kent County, Maryland. I accept the appointment of Treasurer until the final campaign finance report required by the Town of Chestertown is filed or until a successor is duly chosen and qualifies. I understand that should I resign I shall do so with a letter signed by me and filed with the Board of Supervisors of Elections Town of Chestertown, hereinafter referred to as the Board. The candidate committee immediately shall appoint a new treasurer, as the case may be, in accordance with §71.5 Campaign Finance Entities of the Town of Chestertown, Maryland Code of Ordinances. The resignation shall not be effective until a successor is registered with the Board. A treasurer, when resigning, shall certify that he has served until all duties have been performed and a successor was duly chosen. If a treasurer should die or become incapacitated, a new treasurer must be appointed. The Board shall be immediately informed in writing of the name and address of the new treasurer. The candidate and treasurer of the candidate committee are jointly and severally responsible for filing all campaign finance reports required under this chapter. A campaign finance entity may continue in existence in perpetuity. It may be closed, at the option of the candidate.

Important: Even if no transactions have occurred during the reporting period, you are required to file a campaign finance report. The report must be filed timely. Until the last campaign finance report is marked final, the campaign finance entity is presumed active.
